The MDTS system is a patented newgeneration, transdermal drug delivery technology that delivers drugs directly through the skin. For men, VIVUS has completed Phase 2 development of avanafil for erectile dysfunction. The company currently markets MUSE[®] (alprostadil) suppository for the treatment of erectile dysfunction in the U.S. and internationally through distributors.
