Each of the Reporting Persons disclaims beneficial ownership of the shares reported herein except to the extent of its or his pecuniary interest therein, and the filing of this Form 4 shall not be construed as an admission that any of the Reporting Persons is the beneficial owner of any such shares for purposes of Section 16(a) of the Securities Exchange Act of 1934 or for any other purpose.
- Of the shares sold on March 8, 2017, 323,651 shares were held for the account of the Master Fund, 26,349 shares were held for the account of the Account, and all of such shares may be deemed to have been beneficially owned by North Tide and Mr. Laughlin.
- Of the shares sold on March 9, 2017 at a price of \$1.2500, 46,236 shares were held for the account of the Master Fund, 3,764 shares were held for the account of the Account, and all of such shares may be deemed to have been beneficially owned by North Tide and Mr. Laughlin.
- Of the shares sold on March 9, 2017 at a price of \$1.2066, 402,529 shares were held for the account of the Master Fund, 32,771 shares were held for the account of the Account, and all of such shares may be deemed to have been beneficially owned by North Tide and Mr. Laughlin.
- Of the shares sold on March 9, 2017 at a price of \$1.2042, 219,250 shares were held for the account of the Master Fund, 17,850 shares were held for the account of the Account, and all of such shares may be deemed to have been beneficially owned by North Tide and Mr. Laughlin.
- Of the shares sold on March 10, 2017, 71,203 shares were held for the account of the Master Fund, 5,797 shares were held for the account of the Account, and all of such shares may be deemed to have been beneficially owned by North Tide and Mr. Laughlin. As of March 10, 2017, 9,055,144 shares were held for the account of the Master Fund 1,411,556 shares were held for the account of the Account, and all of such shares may be deemed beneficially owned by North Tide and Mr. Laughlin.
